Prior to 2006, ECT at Zomba Mental Hospital was being prescribed excessively and administered without general anaesthesia. The project facilitated introduction of modified ECT and the use of modern equipment and up-to date protocols

 - Malawi Mental Health Research and Practice Development Conferences. 3 annual conferences were held (2011-2013). Approximately 100 delegates from Malawi, UK, USA, Zimbabwe, Zambia and South Africa attended each conference.
 - Establishing an MMed (Psychiatry) postgraduate programme. Prior to 2011 there was no postgraduate psychiatry training in Malawi. A curriculum for a 4-year course was developed. The first 3 trainees commenced the programme in 2011.
 - Equipping of a learning resource centre at Zomba Mental Hospital and improving mental health clinic facilities at Queen Elizabeth Central Hospital.
- **4.** "Enhancing Mental Health Training": Malawi Development Fund, Scottish Government 2013-2016 (£382,180).
 - Malawi Mental Health Research and Practice Development Conferences. 3 further annual conferences were held (2014-2016).
 - District project over 500 primary health care workers were trained in the recognition and treatment of common mental disorders using the WHO mhGAP guidelines.
 - E-learning an e-learning platform and materials for the undergraduate and postgraduate psychiatry courses were developed and are in use by current students and trainees.
