Academic Interests

Corpus methods and digital humanities: Corpora have been my primary research resource since 2020. Besides a synchronic study in cognitive linguistics on *The Coronavirus Corpus*, my work has mainly involved diachronic corpora. I am particularly interested in a critical engagement with corpora as a resource, its advantages over previous non-computational methods, and its application challenges and how they can be addressed. This has been a focus from a research perspective for the past years, but my recent work on the *From Inglis to Scots* corpus has allowed me to engage with these issues from a compiler's perspective.

Historical Phonology: I am keenly interested in the mechanisms of sound changes in languages, especially the effects of language contact. Most recently my research focuses on the Great Vowel Shift, in which Scots has been used to argue for this change being a push chain shift. In my PhD, I investigate spelling evidence of this shift to contribute a Scots perspective to a field that has nearly exclusively studied English.

History of Scots and English: The historical development of these two languages was my first introduction to linguistics, and ultimately the reason I chose a linguistic career. My research in this field has been varied, including evolutionary accounts of pronoun borrowing in English, a socio-linguistic study of the Jacobite Movement in Robert Burns' poetry, and a lexical study on the effect of Romance borrowings in English legal texts.

Dialectology: I have been interested in dialects long before I was introduced to linguistics. The study of language varieties, how they function and spread diachronically and synchronically is utterly fascinating to me. So far, my academic studies focussed on dialects of English and Scots, but beyond that the dialects of Austria and Southern Germany are most on my mind.

Grammaticalisation and Subjectification: Between 2020 and 2022, most of my work encompassed corpus-based research on grammaticalisation and subjectification. My keen interest in grammaticalisation and its semantic, syntactic and phonological effects continues to this day.
